NEW BUSINESS

<u>Open Farm Day-</u> As of now that date has been set for the last Saturday in August 2023. The Agricultural Commission will work on getting Farm Businesses to sponsor our Open Farm Day. The Agricultural Commission wants the Farm Businesses to know that they have all our support in anyway they may need when giving the Town/Agricultural Commission their hand in making the Open Farm Day a success.

<u>Community Garden Update-</u> The Community Garden is in need of new posts and currently some other upkeep. This work could potentially be done on the same work day as Sofinowski Preserve work day. The Community Garden will be tilled in the early spring 2023.

<u>Youth members of commission / Ag education-</u> The commission would like to get a possible Youth Group in the works at the High School for students who are interested in a agricultural and landscaping future. The Commission is interested in doing a presentation at the High School in the near future.
