# BOARD OF HEALTH October 6, 2022

OPENING: The regularly scheduled meeting of the Board of Health opened at 6:00 p.m. The following members were in attendance:

### **MINUTES**

#### **PUBLIC COMMENTS**

There were no public comments.

Mr. White stated that the MAVEN report showed 59 COVID cases in Southwick. He is awaiting the number of vaccines.

## **PUBLIC HEALTH NURSES**

The BOH is waiting for the completion of the nurse's physical exams. Their was a discussion about the nurse's email and cell phones etc. Mr. White will check with the Accounting Dept. to see if they could meet on the 11<sup>th</sup> for any needed paperwork/orientation. Mr. White will provide them with a list of the BOH contacts in other towns.

The BOH voted unanimous to hire the nurses pending completion of their physical exams. The members signed the nurse's Letter of Employment.

## LEGAL ADS

Ms. Brzoska asked if the Board of Health's revised Disposal System regulations were posted in the paper. Ms. Nilsson said that a date was needed and that the legal ad must be posted twice prior to hearing. The hearing will be held on November 3, 2022.

Ms. Nilsson provided details as to when and how to post the regulations and the hearing. She will give the newspaper contact information to Mr. White. Ms. Brzoska asked to have the revised Body Art regulations included in the same newspaper posting and the public hearing.
