MINUTES

Ms. Nilsson made a motion to accept the minutes of January 3, 2018. Dr. Azia seconded the motion. The vote of the Board was unanimous in favor.

ATTENDANCE

Ms. Janice Hoffman, agent for George Adams, attended the meeting to request a variance of the State Sanitary Code which requires an electrical striker mechanism to be installed at the Cedar Street Apartments. Ms. Hoffman explained to The Board that the front doors are rarely used as there is no parking on Cedar Street where the front doors are accessed from. The residents typically access their apartments through their backdoors which lead directly into their apartment. Ms. Hoffman informed The Board that she has installed a self locking handle on the front door of the apartment building that houses apartment 13. Ms. Hoffman is willing to put the self locking handles on the front doors of the 3 remaining apartment buildings. Residents are only able to gain access through the front doors with the key issued to them.

MR. FITZGERALD'S REPORT
