Dr. Azia asked the Board if they would like to revisit the discussion they had about reducing or eliminating fees paid to the Board of Health by establishments that have been effected by the pandemic. Ms. Spencer stated that she has spoken to most of the Boards of Health in Hampden County and none of them have reduced their fees. Ms. Nilsson and Ms. Spencer both explained that refunding fees already paid by establishments would result in an immense amount of work. Ms. Spencer informed the Board that there were establishments that have paid a lesser amount this year due to a change in capacity limits. The Board has removed the Milk and Cream permit this year which resulted in reduced fees as well. The Board would like to see a list of establishments and what they paid in fees for their 2021 Permits.

COVID-19 DISCUSSION

Ms. Nilsson asked for an update on the Southwick Baptist Church. Ms. Spencer visited the church on Sunday and is satisfied with their compliance at this time.

According to the report released by the Department of Public Health today, Southwick has had 8,279 people tested with 344 positive cases. Southwick has had 60 positive cases in the last 14 days. Dr Johnson stated that she is receiving 5-7 positive cases per day, many of them being in the same family. Dr. Johnson stated that the symptoms reported in the last month have been mild and include nasal congestions, sneezing, and head pressure. There have been no new deaths or hospitalizations.

The temporary revisions to the Governor's orders have been extended to January 24, 2021.

Southwick and Agawam will be partnering to hold a First Responder Vaccine Clinic January 11, 2021.

A minimum of 4 sites have been identified to become Regional Mass Vaccination Clinics. They will be open for phase 2 and 3. There will be 2 locations in Western Mass and 2 locations in Eastern Mass. The Town has been preparing for the possibility that towns will need to hold their own vaccine clinics. The Board discussed at length many different aspects of how the vaccine will be distributed. Some of the items discussed included how to register for the vaccine and how the second dose is administered, what types of emergency services would be present at vaccine clinics, how the Town is preparing if they need to hold a clinic, etc...
