- C. Pratt opened the meeting at 7:00 P.M.
- C. Pratt requested a review of the minutes of the May 6, 2020 meeting.

#### **Old Business:**

- J. Theroux presented an overview of the progress to the old cemetery. He stated that there were many repairs already completed to the head stones and the vault. There was a delay in finishing the tree removal, which will also be continued and the sandstone repairs have been halted due to the cold weather. He also stated the sand stone monument restoration was very costly and would be ongoing in the Spring when the weather was warmer.
- D. Clark gave an update on the Agricultural Commissions- Farm Signage. He stated they were able to make more signs than they anticipated and they have been ordered.

### **New Business:**

- C. Pratt stated the annual CP-3 report that is required by the State of Massachusetts had been submitted in September.
- C. Pratt then requested that the committee amend the motion made at the May, 6th meeting to correctly reflect the amount of \$44,500.00 of APR funds previously appropriated be amended from the incorrect amount of \$45,000.00. These funds would be returned to the open space fund.

- C. Pratt presented an informational (38) slide presentation covering the roles and responsibilities, funding and project criteria and past projects relating to the CPC. The PowerPoint covered: responsibilities, taxes and fees, surcharges and funding, project eligibility, local revenue, bonding and leveraging, and the goals of the CPC as a committee. Slides included a chart of the acceptable use categories of open space, historic preservation, community housing, land for recreation and the percentages of financial allocations as well as types of projects in each category. The application process was explained as well as the town's surcharges. Further explanation of the application process outlined with the suggestion that a plan should be looked at, and developed, to better inform the public and other surrounding town's examples were shown.
- C. Pratt reviewed current protocols for new applicants and suggested a more timely notification and review of new applications might be a good idea if they come in between meetings.
- D. Horath asked if we had any new or pending applications and C. Pratt responded not at this time.
- D. Clark explained the process of logging them in through the town clerk's office
- C.Pratt again said it would be good to give the members a heads up if any need applications were to come in prior to meetings.
- D. Clark asked if a call out to possible applicants would be recommended
- C. Pratt said as long as we got applications timely enough to be able to get on the town warrants.
- D. Moglin commented about the dates for submissions prior to town meetings.
- C. Pratt moved the discussion to elections of officers.
- J. Whalley quickly nominated C. Pratt as chairman.
