LPP Extension A letter was submitted to the Select Board requesting that the due date for submitting payment for the Local Permitting Program (LPP) be extended until July 1, 2020. The extension is due to the Coronavirus 19 shutdown. The Select Board unanimously voted to approve the extension at their meeting on 4/28/2020.

Social Distancing Signage Coordinator Clark worked with Tammy Spencer, Health Director, who laminated signs for public areas such as the boat launches, North Pond, Rising Corner and the Sofinowski property. Ms. Spencer did agree that the Granville Gorge could be open to the public. Coordinator Clark and some volunteers did clean the parking area of trash and debris and is working with a contractor to renovate the parking area.

Open Space Online Mapping Coordinator Clark and Chairman Pratt are working on a mapping system where the public may access information on recreational and open space within the Town. Individuals will be able to click on site on the Town homepage and be directed to photos and information relative to hours of operation, rules & regulations, etc. The Conservation Commission will have control over what is/is not presented on the site.

Budget Review Coordinator Clark attended a virtual meeting of the Finance Committee. The Finance Committee denied all of the budget requests made by the Conservation Commission. The Commission will need to wait until the Select Board's Budget Meeting to find out if any of the Commission's Budget requests are restored at their work session.

Alum Treatment The treatment was finalized in South Pond. There was no evidence that the fish kill was a result of the treatment.

112 Sunnyside Road Vice Chairman MacWilliams is working with Mr. Kudlic to complete the ADA accessibility on the trail behind Town Hall and will follow up at the next scheduled Conservation Commission meeting.

61 & 63 College Highway Coordinator Clark stated that there have been no changes since the last meeting. The issues may be on hold until the new Building Inspector has been retained.

Certificate of Compliance DEP# 292-0362 Granville/Fred Jackson Roads Coordinator Clark stated that there has been some changes made to the Granville Road culvert, but not all stabilization has been completed as of this meeting.

81 Point Grove Road Tree Removal Coordinator Clark received a notice concerning a tree that could fall on Point Grove Road or at the culvert between Middle and South Ponds. Mr. Brown agreed that the tree is mostly dead and is cause for concern for boaters on the lake or patrons walking nearby. The tree is on private property.

Granville Gorge Tree Removal Coordinator Clark requested that Mr. Brown evaluate branches at the Granville Gorge that are near/on power lines. Mr. Brown did review the branches and will contact Eversource for their removal.

250th Celebration The Conservation Commissioners will work on a design for the float which may include a waterfall. Vice Chairman MacWilliams has access to a 28 foot trailer and has some building materials available. Coordinator Clark will request if the Agricultural Committee would like to participate in a joint effort for the float.

Woodland Ridge Fencing Vice Chairman MacWilliams received a quote to replace the fencing of \$1,100.00. A purchase order will be submitted to the Accounting Office for approval.
