PUBLIC COMMENTS

Maryssa Cook-Obregon (Zoom) related information from the Agricultural Commission concerning a sign at the Sofinowski Land Preserve. The potential sign(s) will be reflective white with green lettering on both the north and south entrances to the preserve possibly hanging from an L shaped swinging sign post which can be removed during the off season. PUBLIC HEARINGS

Mr. John Tomaszewski, R Levesque & Associates

RDA 1 Hudson Drive Vice Chairman Cheever opened the public hearing by reading the legal ad as posted in The Reminder Publications on October 6, 2022. Commissioner

Reardon, as owner of the property, recused himself from the discussion as a Conservation Commission member. The project is for a self-storage unit that was previously presented, but is now closer to the 50 foot buffer due to a revision in the Storm Water plan. There will be over 1,000 square feet of disturbance that is approximately 16 feet away from the resource area. The Conservation Commission members were in agreement that the project would need to be filed as a Notice of Intent due to the extensive disturbance. Commissioner Drenen made a motion to find the project positive as the project will need to be filed as a Notice of Intent. Commissioner Mizanoglu seconded the motion. 26 Island Way Mr. Jay Stemmler, owner, attended the meeting via Zoom to present information pertinent to a letter issued for nonpayment relative to the LPP. According to Mr. Stemmler stated that the 4 ½ foot dock was mostly on the shoreline, and stated that the float line was only used when the family was in residence due to boats coming close to his shoreline. However, it was present during every site visit by Coordinator Pooler and in the picture taken during the lake survey by Vice Chairman Cheever. Mr. Stemmler also stated that the Town buoy be moved. Vice Chairman Cheever will address the issue at the next Lake Management Committee meeting. Commissioner Reardon noted that all lakefront property owners need to have consistent regulations. Mr. Stemmler did agree to submit a payment for the structure and vessel at the property.

Commissioner Drenen excused himself from the remainder of the meeting at 7:39

Certificate of Compliance 12 Noble Steed SWK 454-123 Coordinator Pooler conducted a site visit and noted that the property was in compliance with their Order of Conditions. 4010 Mountain Road Annual Removal of Docks Ms. Sylvanna Sajenicz submitted an application for a variance in accordance with Section 6.2 of the LPP. Commissioner Patria made a motion to approve the application with the condition that solar lights and traffic barrels be placed at the end of the dock. The request will be reviewed on a yearly basis. Commissioner Reardon seconded the motion. The roll call vote was unanimous in favor:

LMC Update Vice Chairman Cheever stated that there were no updates as of this meeting.

Special Town Meeting Coordinator Pooler stated that a special Town Meeting will be held on November 15th. Coordinator Pooler suggested that a Warrant Article be composed for the establishment of an acquisition account for the purchase of conservation land from CPC funding. There will be insufficient time to create a Warrant Article for this Town Meeting, but Coordinator Pooler will continue to work on a presentation for the Annual Town Meeting.

Forest Cutting Plans Coordinator Pooler spoke with Jacob Macko about a possible site visit at Fred Jackson Road. However unless the Conservation Commission has specific issues Me. Maco informed that a site visit is out of Southwick Conservation Commission jurisdiction. Mr. Macko offered to have a joint meeting with the Conservation Commission members on a Town owned property to explain the workings of a forest cutting plan.

Sofonowski Land Preserve Coordinator Pooler related that the work day was a success clearing sections of the preserve. There were many volunteers including members of the Agricultural Commission who coordinated the effort. Coordinator Pooler consulted with MACC to establish a way to eradicate evasive plants without their seeds spreading. A trap method using tarps was a viable option. There will be more scheduled clean ups. Some items of concern were trail markers and the picnic benches need to be replaced or rehabbed.

Sub Committee Chairman Coordinator Pooler presented a list of structural ways to form the Committee. Town residents have already expressed interest in joining the proposed Committee which will be similar to the former Open Space Committee. It was further suggested to limit the number of members and to have them report directly to the Conservation Commission as they would be focused on land conservation and the issues directly related to the commissions jurisdiction.

Noble Steed Crossing Coordinator Pooler stated that once again the corrective measures taken at the subdivision were limited and some are still failing. There was also fill containing contaminated material brought to the site. Vice Chairman Cheever made a motion to begin fining Mr. Saltmarsh beginning Monday October 24th at \$300.00 per day. Commissioner Mizanoglu seconded the motion. The roll call vote was unanimous in favor:
