Also attending the meeting were 2 members of the public and several people identified on Zoom.

The joint "hybrid" meeting of the Southwick Planning Board Short Term-Rental Subcommittee was scheduled to take place via Zoom and was called to order at 7:00 p.m. by Mr. Brown. He stated that the meeting was being recorded, asked if anyone else was recording the meeting, and asked if all persons could hear via Zoom.

- 3. Public Comments. Marcus Phelps of 28 Depot St. said that in the state bylaw draft short-term rentals can only be in single family homes, no apartments. He also said the home must be owner-occupied.
- 4. Policy Discussion. Mr. Brown discussed the documents he sent to the committee and asked how they felt about them. Mr. Scott said he was still against having these rentals because he was concerned about party houses, trash, complaints and transient traffic. Resident Diane Gale of 5 Point Grove Rd. said that there were only 3 registered with the state in Southwick currently, and she suggested that maybe they should have these rentals register with the state. Resident Jacqueline Senez said that she has a house on the lake that she rents out long term; she is concerned that she will be put into a situation where the tenant moves out.
