Mr. and Mrs. Patel came for a violation hearing which happened on 12/27/19. The specific regulations violated were 204 CMR 2.05 (2) permitting an illegality on the licensed premises to wit: MGL Ch. 138, subsection 34 – sale or delivery of an alcohol beverage to a person under 21 years of age. Additionally, these actions violate Town of Southwick Rules and Regulations concerning liquor sales under page 22, Section 10:01 (2) & (22) as sale was made by a non-TIPS Certified Employee. Liquor Licensing Agent Lt. Landis suggested that they get a Continuation Without a Finding disposition with no other violations happening. He stated the Patel's immediately responded to the violation by purchasing a license scanner for \$5,200.00 and will update every year, and having their employee get TIPS Certified immediately. The Board thanked Officer Massai for noticing and acting on the violation immediately. **A MOTION** was made by Mr. Moglin, seconded by Mr. Deedy (Vote-Unanimous) to
