- Ms. Darosa responded to questions asked by Mr. Fox regarding the 8/26/19 incident.
- Mr. Tracy gave his testimony as to the incidents of 8/26/19, 11/25/19,
- Ms. Darosa responded to the incidents and to the process she has/will be taking to confine her dog to her yard.

- Susan Moszynski gave a synopsis as to the incidents.
- Other neighbors also gave testimony stating they didn't think the dog should be put down. And Ms. Darosa has done everything to contain the dog.

 submitted additional working documents from trainers and behavioral consultant and pictures of
 the dog (Lido) with children. Additionally, a record of dog incident involving Moszynski dog.
- The Board closed the evidentiary part of hearing for taking testimony. They will await a
 recommendation from the ACO and will keep the hearing open until next meeting to determine
 Finding of Fact decision.
