Dear Representative

I am writing to you in regards to the recently released Redistricting Maps. As you are aware, Chapter 56 of the Acts of 2021— An Act relative to Reprecincting allows the legislature to draft their district maps while municipalities are drawing their precinct lines rather than waiting until the municipal Reprecincting lines have been finalized.


It appears that the proposed redistricting maps are using 2010 precinct lines which is problematic for those communities with significant changes, such as the need for reduced or additional precincts, or a new split legislative district. It is important that the legislature take into consideration the work that has been done locally with drafting the 2020 precinct boundary lines and use those as the building blocks for redistricting.

The revision alternative outlined in Chapter 56 of the Acts of 2021, $\S1(c)$ does not provide a viable solution for municipalities. For insert your community here, there is no mathematical way to add an additional precinct within the stipulations outlined in MGL 54 \S 6 without causing a split precinct – this is true for far too many other municipalities as well.

In order to avoid unnecessary split precincts which will cause voter confusion and additional costs to communities, amongst countless logistical issues, we ask that you consider one of the following alternatives:

- Utilize the 2020 re-precincting boundary lines that have been done at the local level as building blocks for your districts even if it hasn't been approved through the LEDRC yet.
- Consider waiting until after the October 30th deadline for municipalities to vote their precinct boundary maps before creating district maps so precinct lines can be used.

It is our desire for the legislature to use the 2020 reprecincting boundary lines approved locally as a basis for redistricting. Thank you in advance for your attention to this matter.
