• The Select Board reviewed a list of infrastructure potential projects funded through American Rescue Plan Act of 2021 (ARPA). The amount of \$1,455,676.27 was awarded to the Town of Southwick. The following projects are to be eligible:

\$600k College Highway waterline improvements

\$300k Prifti Park sewer pump station upgrades

\$220k Flood control weir gates for Great Brook for Congamond Lakes and \$5,500.00 for batter boards as a temporary measure

\$40k Town Wide Buildings for Public Health recommended replacement from current water bubblers to safer designed water bottle filling stations

\$15k for High Speed Internet related broadband improvements and groundwork for establishment of a MLP

The projects listed are a benefit to all for the Town of Southwick.

The balance of funds will be held as a contingency for the projects and until bids received/awarded due to materials delays, potential increases over estimates and supply chain logistics effecting all projects post pandemic.

New Business:

- Lee Hamberg, Chairman Historical Commission and Art Lawler will work on RFP assessment with CPC funds to restore the cupola and roof slate masonry at the Southwick Police Department.
- Tax Title Auction was held on October 21, 2021 @ 12:00 p.m. Estimated total for 10 Second Street is \$34,985.34. 50 South Longyard Road is \$14, 271.83 for a grand total of \$49,257.67. The estimated Excess Proceeds is \$173, 742.33 will be held for 5 years.

DPW update on Sewer System Rates Agreement with City of Westfield for upcoming Fiscal Years. Under the current MOU, the Town is billed a Commercial-Residential rate. Southwick pays approximately \$250,000.00 to Westfield for disposal sewage. The Town will have to begin talks with Westfield on the current and future rates.

Fish & Game site tour @ North Pond to review damage (LMC, ConCom, State Agencies MA DFW & DEP & Harbormaster) meeting date was held on 10/26/2021 Mr. Fox gave an update on the meeting and site tour. There have been violations with an individual excavating the beach area. Fish & Game would consider entering a M.O.U. and provide signage with their rules to help provide more enforcement. Conservation would have to work with DEP to correct erosion and vegetation to re-establish the bulldozed trees that was intended to establish a beach.

It is clearly a dishonor to have this happen when the Town of Southwick paid a major portion of the 5 million dollars including a 15 year bond to preserve the North Pond Property in its natural state. Chief Landis made comments on how it is difficult to patrol the property. There has been improvement with reckless activities, not as many young people gathering and partying. The Police Department will continue to do what they can to monitor and patrol.
