Mr. Russo and Mr. Barr discussed the Town Hall Roof materials, cost, lifespan and HVAC work. Depending on the roof material the cost estimate will range from \$810,000.00 - \$816,000.00. This excludes other project expense like a bid out Architect oversight, Clerk of the Works, lightning protection contingency and soft cost. The actual received bids need to take place. The options are a shingle roof with a life expectancy of 20 years or a membrane material with a life expectancy of 25 – 30 years. The HVAC should not have any disruption during the installation if done in late Fall.
