New Business:

- Tax Classification Hearing FY 23 scheduled for November 7, 2022 at 6:05 p.m.
- ARPA Funds: The HVAC Bid is in the amount of \$1,624,000.00. Approximately \$305k is needed in additional funds to accept the HVAC bid and set aside for contingencies for both roof & HVAC Contracts. There is \$179, 565.65 remaining from FY 22 and FY 23 \$126, 327.35 could be used to offset the funds needed. Mr. Moglin had expressed he would like to see \$1m of ARPA be used towards Fiber Optic for a head start on the project and the possibility of using Stabilization fund to offset costs. Mr. Stinehart explained use of Stabilization requires a Town Meeting vote and it is not time effective for Bid Award and Contract timelines. The Town could miss the opportunity for the HVAC project going forward and in principle be more costly.
- **A MOTION** was made by Mr. Moglin seconded by Mr. Fox (Vote Unanimous) to authorize the use of FY 22 ARPA Funds in the amount of \$179,565.65 and FY 23 ARPA Funds in the amount of \$126,327.35 for the remainder balance of \$305, 893.00 for the HVAC bid and other costs for the project.
