Old Business:

<u>Updated Road and Infrastructure Projects from DPW Director for FY24.</u> The Board went over the project list from DPW with some updated changes with Mr. Randy Brown. Mr. Moglin stated that the projects started in 2024 are still going to happen. There is about \$540,000.00 to allocate amongst the 21 items listed. Mr. Brown informed the board that the Town should be getting FY25 Chapter 90 share and those funds will be allocated in June/July time frame for about \$370k. Mr. Brown is hopeful to get funds at Town meeting also.

• **A MOTION** was made by Jason Perron. **Seconded by** Diane Gale (Vote-Unanimous) to approve Project #3 Feeding Hills Road, Foster to Buckingham drainage in the amount of \$350k and then roll the balance between the 540k and less than \$350k forward into projects for the 2025 season.

Mr. Brown also stated that he would like to reallocate some funds from Point Grove Road. We took funds out of the water & sewer accounts to work on some improvements of Point Grove Road. That project was a little over budget. Mr. Brown stated that it will come out of the \$540k funds.

<u>T-Mobile Hometown grants:</u> Mr. Perron sat with Cara Cartello this past week, they are just waiting on estimates for equipment and the bid from Mr. Shield. Once Mr. Perron has that information he can finish putting the grant together.

Master Plan Implementation Committee: Mr. Moglin gave an update from his meeting with Mr. Dougherty. One Select Board member, a Planning Board member, one resident Select Board appointee, one Planning Board appointee and then one more, not sure if it's a joint appointment. Mr. Moglin would also like to give the committee a mission. To report to the town annually, report to Select Board and Planning Board bi-annually, identify successful strategies and barriers to progress, conduct outreach and provide a conduit for public input and evaluate progress via metrics based on the master plan and other relevant data. Norm Cheevers put metrics and measurements into the master plan so they would be able to use it as a guide to measure progress. The committee should meet maybe every other month/6 times a year.

Mr. Moglin forgot one item under new business, so he will cover it under old business. Mr. Moglin would like for the board to consider allowing Mr. Moglin to craft a proclamation for our next meeting which would be to honor Donate Life month. April is Donate Life month in the Commonwealth. Town hall was lit up a color for the month. We had a previous resident in town that was very big in getting people to donate and sign up to be an organ donor.

Early Voting for the 2025 local elections and future local elections will be on the next agenda, since there is a cost related to it for local elections.
