Bob Johnson, Supervisor of Buildings & Grounds met with the Select Board to request a Reserve Fund Transfer in the amount of \$12,500.00 for HVAC repairs. He explained in detail.

A MOTION was made by J. Deedy, seconded by R. Fox (Vote- Unanimous) to approve the request in the amount of \$12,500.00.

He also informed the Board that Whalley Park is open and there have been no winter leaks in any of the facilities.

Mr. Fox shared a letter from the STGRSD Health Career students of a fundraiser they are sponsoring. The students are raising money for a code blue light system for the track. This would benefit the students and the general public. The Select Board would like to invite them at their April 17, 2018 meeting to speak about the fundraiser to acknowledge this worthy project and arouse interest for others to contribute.

Mr. Moglin would like to invite the Health Agent to the next meeting along with a Police Officer to discuss age enforcement at vape shops.

Old Business:

Mr. Fox discussed the land agreement at the Sofonowski Property. He discussed the funding of the land maintenance should be paid out of a Federal Grant and not the Conservation Commission budget. Agreements and Contracts are to be signed and approved by the Select Board. He added to provide transparency for the next year the Select Board will solicit proposals for a scope of services by qualified individuals. The current arrangement will be kept in place this year.
