This will go to Town Counsel for review.

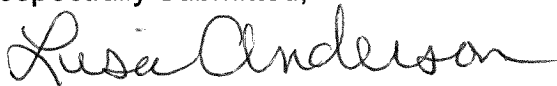
Old Buiness:
