Mr. FitzGerald reported that the facilities were in working order and there were no issues in need of addressing.
- <u>9 Foster Road</u> Mr. FitzGerald stated that this property is in receivership. Mr. FitzGerald stated that repairs are in process including replacing the roof, installation of a new septic system, installation of a new furnace, and general clean-up. Mr. FitzGerald will continue to monitor.
