440 College Highway Mr. FitzGerald received a call from the tenant that occupies the second floor apartment regarding a possible housing code violation. Mr. FitzGerald inspected the property and noted only one means of egress on the second floor which is a possible building/fire code violation. Mr. FitzGerald sent copies of his report to Building Inspector, Fire Inspector and the owner of record.

8 Curtis Road Mr. FitzGerald sent a letter to the owner of record requesting that the debris be removed from the property. Mr. FitzGerald visited the property and spoke with the owner who was actively cleaning up the property at the time of his visit.
