MR. FITZGERALD'S REPORT

87 Klaus Anderson Road Demolition Permit has been obtained.

<u>54 Davis Road</u> Mr. FitzGerald received a complaint from an abutter regarding the condition of the property. Progress is being made on the property but there are still issues that need to be addressed. The pool is not secure and the yard is not in acceptable condition. Mr. FitzGerald is working with Ms. Kara Cunha from the Attorney General's Office to resolve these issues

<u>440 College Highway</u> A permit has been obtained to build a 2nd means of egress within the second floor apartment.

250 College Highway Tenant has filed a complaint with the Select Board stating Mr. FitzGerald failed to document active water/sewage leaks. There were no active water/sewage leaks during Mr. FitzGerald's inspection according to the Health Director and the Building Inspector who accompanied Mr. FitzGerald.

21 Island Way Mr. FitzGerald received a complaint from the tenant stating that the deck and window is rotting and falling apart. Mr. FitzGerald inspected the dwelling and is following up with the owner as the tenant has vacated.

Mr. FitzGerald received a complaint from a woman who witnessed unsanitary practices while visiting Roma Restaurant. Mr. FitzGerald will speak to the owner regarding the complaint.

Mr. FitzGerald received a complaint from a resident on Davis Road regarding a neighbor burning and possibly a septic issue. Mr. FitzGerald will investigate the complaint.
