# MINUTES BOARD OF HEALTH November 1, 2018

OPENING: The regular scheduled meeting of the Board of Health opened at 7:00 p.m. The following members were in attendance:

#### **MINUTES**

Ms. Nilsson made a motion to accept the minutes of October 4, 2018. Dr. Azia seconded the motion. The vote of the Board was unanimous in favor.

## MR. FITZGERALD'S REPORT

- **87 Klaus Anderson Road** The dwelling has been demolished.
- <u>440 College Highway</u> The second means of egress has been completed. The case has been dismissed.
- **250** College Highway Mr. FitzGerald and Mr. Lawler have completed their inspection reports on the property. The tenant was not satisfied and contacted the state Housing Inspector Scott Koscela. Mr. Koscela was satisfied with the inspections and the reports done by Mr. FitzGerald and Mr. Lawler.
- <u>Apartment 13 Cedar Street Apartments</u> The owner of record is in the process of rectifying the minor code violations within the apartment.
- **21 Island Way** Mr. FitzGerald issued the letter of violation to the owner.
- **86 Summer Street** Mr. FitzGerald received a complaint regarding sewage in water outside the residence.
- <u>52 Cooley Street</u> Mr. FitzGerald received a complaint from a woman alleging that children living in a nearby residence are being forced to defecate outside. Mr. Art Lawler, Building Inspector, contacted Protective Services. Mr. Lawler and Mr. FitzGerald will inspect the property in the presence of Protective Services.
- <u>810 College Highway</u> There has been no progress made on the property. Mr. FitzGerald has filed for a show cause hearing in Housing Court.
- **10 Second Street** (Sewer shut-off) Mr. FitzGerald inspected the property and did not notice any signs of sewage. The residence is currently occupied.
