Discussion:

Discussion:

- S. Fox spoke in favor for B. Horacek because of his experience on the Cable Committee.
- J. Horacek said B. Horacek would be a good candidate because he's on several Committees and that she would like to see a little change.

A MOTION was made by D. Gunn to nominate C. Pratt as Chairman of the Committee. The motion was not seconded.

A MOTION was made by S. Fox to nominate J. Horacek as Vice Chairman of the Committee. The motion was seconded by M. Seddon. Chairman called for a vote.

(Vote: Yes: 4, No: 4)

Discussion:

DeMaio had amended the minutes to instead state "On the bottom of page 2 when referring to the school playground please change the wording to "they have not looked into possible alternative solutions where the present playground exists" as I was concerned that Ms. Willard was going to try and come back for money from the CPC without doing proper due diligence to seek a more economical solution with regards to the drainage issue."

A MOTION was made by C. Pratt to accept the minutes as amended, D. Sutton seconded. (Vote: Unanimous)

Review and approve the minutes of February 1, 2018

A MOTION was made by B. Horacek to accept the minutes and D.Sutton seconded. (Vote: Yes: 5, Abstained: 3- S. Fox, M. Seddon, J. Horacek)
