Written Minutes

- C. Pratt opened the meeting at 7:05 P.M. via Zoom
- He welcomed all and began by discussing old business

Old Business:

- C. Pratt asked the members if they had a chance to review the revenue sheets and discussed that there was money available for various projects.
- There was no news of any ongoing projects submitted or new applications so the meeting moved on to New Business.

New Business:

- C. Pratt explained the application process and suggested we get the word out we are looking for new projects for this spring.
- D. Clark stated the applications were available and they could be brought to the Town Clerk's Office and we could review them to see if they meet the criteria and present them at the next town meeting in the spring.
- C. Pratt suggested any worthy applicant should apply.
- D. Clark explained any applications should come in by the end of February in order to be able to get on the warrant for the annual town meeting he stated that funds were available and suggested that they accept applications up until the end of February.
- C. Pratt Agreed that that would give the committee enough time to review the applications and asked D. Moglin what he thought.
- D. Moglin responded it would depend on when the town meeting was scheduled for and he though even the end of February or into March would be enough time.
- C. Pratt agreed that we could wait and give time for applications to come in.

- C. Pratt made a comment about a zone application for an APR (Prifti) project and stated it was the only one he currently knew about.
- J. Whalley stated that the Park & Recreation committee was considering a Spray Park to be added to the Whalley Park, and there was some agreement that they might be a good project.
- C. Pratt Stated that there was a spray park in Longmeadow and he felt it was worth looking into.
- J. Whalley thought it would be a nice addition during the hot weather.

- D. Clark suggested they place it on their agenda to discuss further.
- D. Clark also suggested that "Pickle Ball," might be another thing to consider. •
- C. Pratt agreed that it was a fast growing sport and it could be done on the old tennis courts.
- Discussion was ended and a call to put forward a motion to accept the October 28th. 2020 minutes was made.
