**ARTICLE 1**. To see if the Town will vote to appropriate and transfer from available funds (General Salary Reserve, Water and Sewer Salary Reserve and Water Retained Earnings) the sum of \$134,947.00 for the following salary accounts:

Requested by the Select Board, Sewer Commission, Board of Health and Water Commission ARTICLE 1 EXPLANATION: This transfer from existing funds covers negotiated agreements for staff, several unions and cost of living adjustments for a total of 60 plus employees in the present fiscal year. These funds come from several Salary Reserve Accounts and available funds, set aside to cover these costs. Funds also cover backfill expenses for people out with on the job injuries and sickness.

**ARTICLE 2:** To see if the Town will vote to appropriate and transfer from available funds (Free Cash) the sum of \$321,650.00 for the following Operational Line items of take any other actions relative thereto:

Snow/Ice Removal \$300,000.00

Town Hall Repair and Maintenance \$15,000.00

Police Department Uniforms \$6,650.00

Requested by the Police Department, DPW and Select

Board

ARTICLE 2 EXPLANATION: (A) The Town experienced snow and icing events beyond what was budgeted, some of which required overtime and the use of outside hired vendors. The cost of road salt to treat roads contributed heavily to these expenses. This will allow the Town to close out its books in balance without a snow/ice deficit as of June 30th. Otherwise the deficit would be added to next fall's tax bill. (B) Replenishes maintenance account for Town Hall for activities to complete the fiscal year. The facility is over 20 years old. (C) Southwick Police Department dress uniforms negotiated with Local IBPO Unit.

**ARTICLE 3:** To see if the Town will vote to appropriate and transfer from available funds (Free Cash) the sum of \$450,085.00 in connection with the following Capital Items or take any other action relative thereto:

Granville Road Culvert Replacement \$422,085.00

Depot Street Sidewalks \$ 10,000.00

Library Carpet Replacement \$ 18,000.00

Requested by the DPW and Select Board

<u>ARTICLE 3 EXPLANATION:</u> (A) Funds are requested to replace a failing culvert on Granville Road. The project is designed and permitted and these funds will allow construction.

(B) Funds for sidewalks on Depot Street near the entrance to the Rail to Trail. This will enhance access off trail to a new abutting house subdivision and our downtown area.

(C) Carpet replacement for Library to replace the main common room area that is worn out.

**ARTICLE 4.** To see is the Town will vote to appropriate and transfer from available funds (Free Cash) the sum of \$20,000.00 to the Other Post Employment Benefits Trust Fund (O.P.E.B.) established under the provisions of M.G.L. Chapter 32B, Section 20 or take any other actions relative thereon.

ARTICLE 4 EXPLANATION: This article allows us to make our annual deposit to the Other Post Employment Benefit (OPEB) Trust Fund established at a Town Meeting years ago. The Town currently pays for post employment health care expenses on a pay as you go basis. This type of fund, which was authorized by State law, provides a tool for municipalities to recognize the liability and begin to cover future costs. Eventually this fund will hold several hundred thousand dollars to cover health costs. Annually contributing to it is recommended by our outside Auditors and is looked upon favorably by our Bond Rating Agencies.
