## Town of Southwick Board of Health and Select Board COVID-19 Update for December 31, 2020

As of Wednesday, December 31, 2020, there have been 284 positive cases of COVID-19 in the Town of Southwick. The Southwick Board of Health would like to stress that this is not a complete profile of the status of COVID-19 in the Town of Southwick. This number reflects those individuals who have received positive test results and *not* those awaiting results, untested symptomatic individuals, and those who might currently be asymptomatic. Changes to Travel Order: All visitors and returning residents entering Massachusetts must follow the <a href="new travel">new travel</a>
<a href="mailto:orders">orders</a>. All travelers arriving to Massachusetts – including Massachusetts residents returning home – are instructed to complete the <a href="massachusetts Travel Form">Massachusetts Travel Form</a> prior to arrival and to self-quarantine for <a href="mailto:10 days">10 days</a>, except travelers from Hawaii. All persons are instructed not to travel to Massachusetts if they are displaying symptoms of COVID-19.
