## Town of Southwick Board of Health and Select Board COVID-19 Update for February 12, 2021

As of the most recent weekly public health report, there have been 451 positive cases of COVID-19 in the Town of Southwick. The Southwick Board of Health would like to stress that this is not a complete profile of the status of COVID-19 in the Town of Southwick. This number reflects those individuals who have received positive test results and *not* those awaiting results, untested symptomatic individuals, and those who might currently be asymptomatic. The Town of Southwick's Vaccine Taskforce is currently in the process of preparing for clinics to serve the 75 and older population. Once vaccine has been made available and a date has been set, another town wide message will go out informing eligible residents on how to sign up. Additionally, information will be posted on the Town's website, <u>southwickma.org</u>, and through Channel 15. In preparation for signing up for these clinics, it would be helpful for those interested to keep their insurance information handy and to talk to family members or people they trust to assist them with online registration. Additionally, the Governor announced the formation of a vaccine hotline to assist seniors, aged 75 and up, with locating and signing up for the vaccine. The number to call is 2-1-1. • NEW INFORMATION - Effective Thursday, February 11th, an individual who accompanies a person age 75 or older to one of four mass vaccination sites (Gillette Stadium in Foxboro, Fenway Park in Boston, Eastfield Mall in Springfield, and the Doubletree Hotel in Danvers) to receive the vaccine will be eligible to receive the vaccine too, if they have an appointment booked. Both the companion and the individual age 75 or older must have an appointment for the same day and both individuals must be present. Only one companion is permitted. The companion must attest that they are accompanying the individual to the appointment. Companions may begin booking appointments the morning of February 11th.

All visitors and returning residents entering Massachusetts must follow the <u>travel orders</u>. All travelers are instructed to complete the <u>Massachusetts Travel Form</u> prior to arrival and to self-quarantine for 10 days or produce a negative COVID-19 test result that has been administered up to 72-hours prior to your arrival in Massachusetts, except travelers from Hawaii. All persons are instructed not to travel to Massachusetts if they are displaying symptoms of COVID-19. Individuals who are COVID-19-recovered, meaning individuals who tested positive more than 10 days but less than 90 days ago and who do not have symptoms, do not need to obtain a negative PCR test prior to traveling to, or quarantine upon arrival to, Massachusetts.

The Town Hall north side lobby is open to the public for Town Clerk, Treasurer, Collector, and Assessors services. All other offices are available by phone, on-line, and by appointment. Due to the nature of our operations during the pandemic, please call these other offices before visiting Town Hall. All efforts have been made to ensure that customers and staff are kept safe. The Town of Southwick asks all visitors entering the building to abide by all posted signage.

Due to the continued rise in cases of COVID-19 in Massachusetts, residents are urged to continue to follow all public health precautions for reducing the spread of COVID-19: stay home unless absolutely necessary; if you must go out in public, practicing social distancing and proper hygiene etiquette; wear face coverings when inside

retail stores and when social distancing cannot be maintained; and if you are experiencing signs of illness - fever, cough, shortness of breath – call your primary care provider for advice.
