Town of Southwick Board of Health and Select Board COVID-19 Update for October 23, 2020

As of Friday, October 23, 2020, there have been 90 positive cases of COVID-19 in the Town of Southwick. The Southwick Board of Health would like to stress that this is not a complete profile of the status of COVID-19 in the Town of Southwick. This number reflects those individuals who have received positive test results and *not* those awaiting results, untested symptomatic individuals, and those who might currently be asymptomatic. Early Voting for the November 3rd Presidential Election starts October 17th and runs through to October 30th in the Southwick Town Hall Auditorium. Hours of operation are: Friday October 23 from 8:30am to 4:30pm; Saturday October 24 and Sunday October 25 from 8am to 12 noon; October 26, 27, 28, and 30 from 8:30am to 4:30pm; and Thursday October 29 from 8:30am to 6:30pm. If you don't have one, one will be provided for you.

Due to the nature of the demand on Town Hall staff for the November 3rd Presidential Election, the Town Hall north side lobby will not be open to the public on November 3rd. Services will continue to be available over the phone and online on that day. On all other days, the Town Hall north side lobby is open to the public for Town Clerk, Treasurer, Collector, and Assessors services. All other offices are available by phone, on-line, and by appointment. Due to the nature of our operations during the pandemic, please call these other offices before visiting Town Hall. All efforts have been made to ensure that customers and staff are kept safe. The Town of Southwick asks all visitors entering the building to abide by all posted signage.

All visitors and returning residents entering Massachusetts must follow the <u>new travel orders</u>. All travelers arriving to Massachusetts – including Massachusetts residents returning home – are instructed to complete the <u>Massachusetts Travel Form</u> prior to arrival and to self-quarantine for 14 days, <u>except travelers from California</u>, <u>Connecticut</u>, <u>District of Columbia</u>, Hawaii, Maine, New Hampshire, New Jersey, New York, Vermont, and <u>Washington</u>. All persons are instructed not to travel to Massachusetts if they are displaying symptoms of COVID-19.
