Also attending the meeting were several people in person and identified on Zoom.

The joint "hybrid" meeting of the Southwick Planning Board Master Plan Advisory Committee (hereinafter referred to as the MPAC) and the Planning Board was scheduled to take place via Zoom and was called to order at 6:30 p.m. by Mr. Phelps. He stated that the meeting was being recorded, asked if anyone else was recording the meeting, and asked if all persons could hear via Zoom.

- 1. <u>Roll call for attendance of Committee Members</u> Mr. Phelps noted that there was no quorum of the Planning Board at this meeting.
- 2. Introduction from Marcus Phelps, MPAC Chair & Planning Board Vice-Chair
- 3. <u>Pioneer Valley Planning Commission Presentation: What is a Master Plan?</u> <u>Southwick Yesterday, Today & Tomorrow</u>

Ken Comia of the Pioneer Valley Planning Commission introduced himself and Mr. Goddard shared his screen to show Mr. Comia's slideshow that described the Master Plan staffing and their areas of expertise. It also gave them an idea of what participants would be working on that evening and described a Master Plan and what it is. Mr. Comia told participants that the Town of Southwick has already done a Master Plan in 1967 and 1997(although the 1997 one was not adopted). They also have a Community Development Plan, Hazard Mitigation Plan, Municipal Vulnerability Preparedness Community Resilience Building Workshop and Open Space and Recreation Plan.

Mr. Comia went into great detail explaining why Visioning and Data are important for the town as it surveys the residents' sentiment on goals and recommendations.

4. Break-Out Rooms & Collaboration: "SWOT" Analysis

Strengths, Weaknesses, Opportunities and Threats (SWOT); the participants and committee members broke into groups for an hour to discuss these exercises. When everyone reconvened, they presented their findings.

5. Discussion: Next steps for Master Plan

Mr. Comia shared websites and links for the participants to continue to stay engaged and showed them how to use the links. Mr. Phelps thanked everyone for their participation and help. Being no further business to be brought before the committee, A **MOTION** was made by Mr. Moglin and **SECONDED** by Mr. Cheever close the meeting at 8:28 p.m. The motion passed unanimously.
