#### **Whalley Park**

## Rail Trail

Review Hartline \$3,557 quote to re spray the existing painted markings on the bike trails. The area is approximately three miles from Point Grove Road to the Westfield town line. Approximately 20 trees need to be removed along the trail. It will cost \$150 per tree to remove them. Review Dudek & Co \$525 quote to fill all the major cracks in three designated areas on the trail.
