# **Public Comment**

Jon Goddard is the town's Stormwater Coordinator. The town properties need to follow EPA regulations. Whalley Park property is fertilized. We need to make sure using a slower release fertilizer and the best product to keep in the ground. He could talk to staff to find out how trash is managed. There are no dumpsters at the park. Advise staff to clean the decks from mowers over grass areas. At this point he needs to make staff aware of EPA regulations. John asked Jon if he has any comments on a spray park. Jon said to make sure chlorine products are properly stored. Jon will talk directly to the company which fertilizes the park.

## Rail Trail

## **Whalley Park**

Discuss a Spray Park. John will get pricing for the two different options. The options would be contained versus not contained water. He believes a spray park would be a great asset to the town.

Currently Southwick does not have a spray park. When it is 90' outside the park isn't busy. Doug
asked if we could get a hybrid version. Possibly a huge tank in the ground for spray park and
irrigate the lawn in the evening with it. This way the water wouldn't need to be treated. Jeanne
stated to keep in mind the park is built on aquifer.
