Levesque Associates to see what we need to do to close out the job. Frank Montaga would like to hold High School girls and boys soccer under the lights for four dates in September and October. They will need to raise \$1,000 to pay for the light use. Dave suggested they look to the Booster Club to collect \$5 per car admission. The maintenance employee's will work every other week in October & November so they can stay on top of leaf clean up. John said heaters were installed in the first and last bathrooms. Wayne Parker said he needs more clay bricks to maintain the 90' pitchers plate. It is damaged in front of the plate. Dave said he will contact JB about the clay bricks.

Rail Trail

Dean would like to clean up the leaves along the trail in November. He will mow every 2-3 weeks in September, October and clean the leaves up in November. Cara and Brooks Martyn from the FOSRT met with Dick Grannells about the cracks on the rail trail. Dick will contact an arborist to identify the roots causing all the damage.
