6:05 pm Troy Henke/Rick Marcoullier RE: Veterans Memorial Upgrade

The above came to discuss the Board possibly donating some monies towards purchasing another panel for the War Memorial on the Town Green. This panel would be for individuals who entered military service from some place other than Southwick, yet lived in Southwick most of their lives. The Town/VFW and American Legion feel they should be honored also even though not born here. They would like to unveil the new panel during the Town's Grand 250th parade. Total cost is approximately \$5,000.00 and they have raised \$463.00 to date. **A MOTION** was made by Mr. Moglin, seconded by Mr. Deedy (Vote-Unanimous) to approve approximately \$2,300.00 left over from the last War Memorial Grant Project, and \$500.00 from the Selectmen's Gift Account. It will be used for this new round of updates to the War Memorial at Town Common.

A MOTION was made by Mr. Fox to appoint Mr. Girard, there was no second, therefore the MOTION FAILED. A MOTION was made by Mr. Moglin, seconded by Mr. Deedy (Vote-Unanimous) to table the decision for a week.

- A MOTION was made by Mr. Moglin, seconded by Mr. Deedy (Vote-Unanimous) to approve the Conservation Restriction for The Greens of Southwick (west side) that Counsel amended.
- Mr. Stinehart stated the surplus sale items are almost all sold and picked up and/or disposed of.
- Mr. Fox attended a ceremony held in honor of an employee of the Senior Center, Denise Hills-McGarry. She saved the life of one of the members of the Senior Center when she started choking on her lunch.

New Business:

 Mr. Moglin went to the last Planning Board meeting. Some residents inquired about solar being allowed in residential zones if they are large parcels. He expressed his desire for the Town to come into compliance with their own bylaws (i.e. sign by-laws). Take under advisement.

New Business cont.:

- The Board discussed the VFW Bingo equipment that was donated to the Senior Center. She stated it wasn't in the greatest of shape. She has asked a local non profit entity for a donation however A MOTION was made by Mr. Moglin, seconded by Mr. Deedy (Vote-Unanimous) to take the monies out of the Select Board Gift Account for a TV and computer program for bingo for the seniors.
- Mr. Deedy stated he is looking into the opportunity to purchase the school's mini
 vans if there is left over monies from the previous year's grant money.
- A MOTION was made by Mr. Moglin, seconded by Mr. Deedy (Vote-Unanimous) to set up a meeting with Police, Fire, Conservation Commission, and Park and Rec. to discuss a Usage Policy for signage on Town Property such as parks, beaches, etc.
