New Business:

Status of meeting with CPC for reconsideration of Town Hall Roof Design Application. Mr. Fox had a discussion with Chris Pratt, Chairman of the CPC to reconsider the application for the roof design at Town Hall. Mr. Fox explained to Mr. Pratt that the Select Board received legal opinion and the roof project falls within the criteria of a Historical Project. This cost will now fall on the tax payers. Mr. Pratt felt there was no reason to hold another CPC meeting that the CPC had made their decision. The CPC does support the slate roof repair at the Police Department. The Select Board discussed that at the Historical Commission meeting they voted to approve the Town Hall Roof Design, but when voting member atended the CPC meeting it was voted against. The project has been dismissed by the CPC which has left the Select Board frustrated but will possibly try again.
