- Russ Fox said that the Veterans Day Parade was well attended. It was great that the people were able to see the changes at the Veterans Memorial in person.
- Chairperson Fox also attended the 100th Birthday Party for the three members at the C.O.A. That they also had a few in the spring also.

Any New Business

Doug Moglin – New Business:

 Doug stated that he would like to carry out into the future a conversation with the BOH regarding the composition & makeup of the Board. A town historian stated a little history that back in the 70's/80's the Select Board was the Board of Health Agents. Russ Fox greed that a discussion should take place.

Jason Perron – New Business:

- Jason wanted to let the Board know he had a round table this past week and the
 question that kept coming up was about the Community Compact grant funding
 and where the monies will come from. Doug stated that it could come from various
 places such as Federal and State.
- The other question was patrons wanted to know if someone could come talk to the Board and explain the process for our tax rate.
 Doug Moglin gave a short explanation of how they get the tax rate. Russ Fox said that we possibly might be able to get Roy Bishop in to explain it.
- Jason also stated that he talked with Jen Nolasko and she would like to come talk
 to the Select Board regarding the sale of Lake 101. Russ Fox stated that cannot
 be done, that they cannot discuss her issues in public.

Old Business:

Russ Fox:

- Mr. Fox wanted to remind the Select Board that there is a meeting coming up with the Southwick-Tolland-Granville Regional School, FY24 Budget meeting at PMMS Library at 5:30pm. It is open to the public. Last year the state notified the Town that they had to come up with 856,000 more.
- North Pond violations seek meeting w/Departments, MA Fish & Game & DEP to review solutions. This is still on going. Mr. Fox stated that we hope to do some tree trimming in winter time. Chief Landis is working with ConCom on security issues.
- Sewer System IMA with City of Westfield update, a meeting between Ben Coyle, Randy Brown, C.A.O. and Mr. Fox to figure out the best way to approach it. This will be a vote on the next ATM.
- Review Southwick PB Comprehensive Impact Statement Hand Book
- Marijuana dispensary-review again for vote
- Town Website meeting calendar. Jason stated he met with Jim Middleton and he added a drop down menu for meeting schedules. There is a direct line to each board. You can also click on each board you would like to receive notification from.
- Marijuana Host Agreement for Hudson Drive facility. This is ongoing, Lawyers talking to Lawyers.
- Assistant C.A.O. Position was reposted with a increase in pay. There were a few great candidates that have been interviewed.

Doug Moglin:

 Article regarding the light plant passed at the STM in November. Now it needs to pass at the next ATM in May 2023.

- The master plan update, created focused groups and a group will be analyzing the data from the survey. It will be posted eventually on the website.
- We need to follow up on the MMA Conference.
- Mr. Moglin met with the Board of Health regarding the Ecoli testing issue. Alex set up with Jim Middleton a way to post future results on the webpage, and it'll allow people to see the results and make their own decision on whether to go swimming or boating.
- Mr. Moglin stated that this past weekend he participated in the Seniors helping Seniors program. A great program with high school honor students working with he COA to help clean up their yards. They helped 6 homes. Cindy Sullivan (COA Director) along with Chief Stafanowicz, Chief Landis and others and the students from the high school did a fabulous job.

Jason Perron:

 Mentioned that Mrs. Lamoureaux mentioned Eversource and if the Town residents had a choice to pick. Mr. Perron stated he researched it and that the residents cannot bargain with Eversource. It is State controlled.
