Mr. Fox reported his interview on Ch. 15 with Mr. Mueller, Lake Management to go over various topics on Congamond. Mr. Fox stated how valuable and fortunate we are to have Mr. Mueller and his knowledge on the Lake Management Committee and recognition to Mr. Grannells too. Mr. Grannells is submitting a grant that if approved funds will be available where Lake Management can withdraw \$45,000.00 FY 24 Budget Request for bathymetric measurements around the Lakes.

A dedication in memory of George LeBlanc was held on February 9, 2023 at the STGRSD. Mr. LeBlanc was highly regarded not only in his capacity as an educator but in the community as well.

Mr. Moglin discussed the survey results for recreational cannabis.
