A MOTION to go into Executive Session Pursuant to M.G.L. Chap. c. 30A, S21 (2), (3), & (4) and Ch. 214, Section 1B Labor Counsel, Police Chief and ConCom Litigation Matters and Strategy for Collective Bargaining with Police Union Coalition, Clerk Union/T.C.C. position, and deployment of security devices on town properties Executive Session RE: M.G.L. Chap. c. 30A, S21 (2) & (3) Ch. 214, Section 1B and;

Exception #2: Move to go into Executive Session to conduct collective bargaining sessions, with nonunion personnel and to: not to reconvene in Open Session (Chair Must Declare). Move to go into Executive Session to conduct contract negotiations with nonunion personnel, and to: not to reconvene in Open Session (Chair Must Declare). declare that an open meeting may have a detrimental effect on the bargaining position of the body, and to not to reconvene in Open Session (Chair Must Declare). Exception #3: Move to go into Executive Session to discuss strategy with respect to collective bargaining and that the Chair Move to go into Executive Session to conduct strategy sessions in preparation for negotiations with nonunion personnel, and to Not to reconvene Open Session (Chair Must Declare). Move to go into Executive Session to discuss strategy with respect to litigation, and that the Chair declare that an open meeting may have a detrimental effect on the litigating position of the body, and to: not to reconvene in Open Session (Chair Must Declare). Exception #4: Move to go into Executive Session to discuss the deployment of security personnel or devices or strategies with respect thereto, and to: Not to reconvene Open Session (Chair Must Declare).

RE: Ch. 214, Section 1B

A person shall have a right against unreasonable, substantial or serious interference with their privacy. The superior court shall have jurisdiction in equity to enforce such right and in connection therewith to award damages.
