Exception #1: X Move to go into Executive Session to discuss the reputation, character, physical condition

or mental health of an individual, rather than professional competence of an individual, or to discuss the discipline or dismissal of, or complaints or charges brought against, a public officer, employee, staff member or individual and not to reconvene into Open Session Move to go into Executive Session to consider the discipline or dismissal of or to hear complaints or charges brought against, a public officer, employee, staff member, or

individual and to not reconvene into Open Session

Exception #3: X RE: Threatened Litigation

Move to go into Executive Session to discuss strategy with respect to litigation, and that the Chair declare that an open meeting may have a detrimental effect on the litigating

position of the body, and to not reconvene into Open Session

RE: Ch. 214, Section 1B
