GREETINGS:

ARTICLE 1. In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of said town qualified to vote in elections and town affairs to meet and assemble at the TOWN HALL, 454 COLLEGE HIGHWAY, PRECINCTS I, II, & III, in said Southwick on Tuesday, May 11, 2010, between the hours of 7:00 A.M. and 8:00 P.M. to elect on one ballot the following officers: One Selectman for a three-year term. Two Regional School District Committee members each for a three-year term. One Assessor for a three-year term. One Cemetery Commissioner for a three-year term. One Dickinson School Trustee for a three-year term. Two Library Trustees each for a three year term. One Park and Recreation Commission member for a three-year term. One Planning Board member for a five-year term. One Water Commissioner for a three year term. One Board of Health member for a three-year term. One Housing Authority member for a five-year term. One Housing Authority member for remainder of term. Two Constables each for a three-year term.

ARTICLE 2. To see if the Town will vote to accept the reports as published in the Annual Town Report of the Selectmen, Assessors, Town Accountant, Town Clerk, Water Commissioners and all others to be acted thereon, or take any other action thereon.

Requested by the Board of Selectmen

Article 2 Explanation: *This is a General Housekeeping Article to authorize the Selectmen to operate Town Government.*

ARTICLE 3. To see if the Town will vote to instruct the Selectmen to appoint minor officers or to take any other action relative thereon.

Requested by the Board of Selectmen

Article 3 Explanation: *This is a General Housekeeping Article to authorize the Selectmen to operate Town Government.*

ARTICLE 4. To see if the Town will vote to authorize the Board of Selectmen to sell or trade obsolete equipment or take any action relative thereon.

Requested by the Board of Selectmen

Article 4 Explanation: *This is a General Housekeeping Article to authorize the Selectmen to operate Town Government.*

ARTICLE 5. To see if the Town will vote to authorize the Board of Selectmen to apply for and accept any and all grants from private entities, the Federal Government or the Commonwealth of Massachusetts for the purposes for which said grants are authorized, or to take any other action relative thereon.

Requested by the Board of Selectmen

Article 5 Explanation: *This is a General Housekeeping Article to authorize the Selectmen to operate Town Government.*

ARTICLE 6. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Board of Selectmen, to issue bonds, notes, and certificates of indebtedness for a period of not more than two years in accordance with M.G.L. Chapter 44, Section 17 or take any other action relative thereon.

Requested by the Board of Selectmen

Article 6 Explanation: *This is a General Housekeeping Article to authorize the Selectmen to operate Town Government. It allows for temporary borings in anticipation of receiving tax receipts, grants, bond proceeds, etc. that fund the operations of the Town.*

ARTICLE 7. To see if the Town will appropriate \$200,000 to pay costs of purchasing and originally equipping an ambulance, and for the payment of all other costs incidental and related thereto; to determine whether this amount should be raised by taxation, transfer from available funds, borrowing or otherwise, or to take any other action relative thereto.

Requested by the Board of Selectmen and Fire Department

Article 7 Explanation: *To replace our 1995 Ford ambulance, which is developing rust problems, and costly repairs to keep in service. It is undersized for the amount of equipment that we need to carry leaving only the bare minimum state required items on board. By replacing this ambulance and using the new one as the first due, it allows both ambulances to last longer as well as allowing an ambulance to stay in service while one is out for maintenance, repairs or on a call thus reducing our need to rely on another community. This replacement ambulance will be purchased out of ambulance revenue.*

ARTICLE 8. To see if the Town will appropriate \$700,000 to pay costs of constructing and originally equipping two water system pump stations to be located in the Coes Hill Road and Granville Road areas of the Town, and for the payment of all other costs incidental and related thereto; to determine whether this amount should be raised by taxation, transfer from available funds, borrowing or otherwise, or to take any other action relative thereto.

Requested by the Water Commissioners

Article 8 Explanation: *The Water Department plans to replace the half-century old Granville Road and Coes Hill Road water pumping stations that boost the water pressure to homes west (uphill) of the pumping stations. There are major reliability and performance issues with both pump stations and some repair parts are no longer available. The existing underground stations will be replaced with above-grade turn-key booster pump stations with dual-redundant pumps and controls that will each be housed in a small aesthetically appropriate pre-cast concrete building.*

ARTICLE 9. To see if the Town will vote to fix the compensation of elected officers and town employee salaries where stipulated, provide for a reserve fund, provide a sum of money for Capital Outlay for the following Town Departments: Town Clerk, Public Safety Buildings, Computer, Town Hall, Police, Fire, Lake Management, DPW (various divisions), and Emergency Management and determine the sum of money the Town will raise and appropriate including appropriations from available funds to defray charges and expenses of the Town including debt and interest for the ensuing FY July 1, 2010 to June 30, 2011 or to take any other action relative thereon.

Requested by the Finance Committee

Article 9 Explanation: *Highlights:
Revenues:*

- **Current local aid numbers from House Ways/Means Local Aid Resolution**
- **No levy limit increase**
- **Reduced New Growth**
- **Application of Free Cash for outright capital purchases or projects**
- **Presumes water/sewer increased budgets supported by retained earnings or rate increases if necessary**

Expenditures:

- **No new positions except for an EMS funded FF/EMT position**
- **Accommodates fixed expenses for fuels, utilities, insurances, personnel and employee benefit costs**
- **Funds for tax title services to bring in money owed to the Town**

ARTICLE 10. To see if the Town will adopt the following vote or to take any other action thereon:

Voted: to re-authorize the Revolving Funds under M.G.L. Chapter 44 Section 53E → for FY2011 entitled "Inspector's Revolving Fund", the establishment of which is for the purpose of compensating various inspectors employed by the Town for services rendered and said fund shall not exceed \$40,000.00 limit on the funds on deposit, or take any other action relative thereto.

Requested by the Board of Selectmen

Article 10 Explanation: *This vote re-establishes an "Inspector's Revolving Fund" to ensure inspectors (electrical, plumbing, gas, fire, etc.) are compensated in direct relationship to the number of inspections made and fees received by the Town.*

ARTICLE 11. To see if the Town will adopt the following vote or to take any other action thereon:

Voted: to re-establish a revolving fund pursuant to M.G.L. Chapter 44, Section 53E → for FY2011 entitled "Public Safety Departments Revolving Account" the use of which is for the Fire and Police Departments in the Town of Southwick to offset costs of training personnel; purchasing supplies and equipment; costs of maintenance and repairs of equipment and vehicles; and salaries paid to details, all related to HAZ-MAT response, and said fund shall not exceed \$40,000.00 limit on the funds on deposit, or take any other action relative thereto.

Article 11 Explanation: *This vote re-establishes a mechanism for the Town to recover costs related to hazardous material spills at accident scenes. This tool is used in municipalities to limit taxpayer expense in responding to and cleaning up accident spills where fire and police budgets take a hit. It is estimated it would only come into play a couple of times a year when large cargo trucks experience accidents that have large spills.*

ARTICLE 12. To see if the Town will adopt the following vote or to take any other action thereon:

Voted: To reauthorize a revolving fund under M.G.L. Chapter 44, Section 53E → that may be spent by the Lake Management Committee without further appropriation, during FY 2011 to pay for salaries, expenses, operations, contractual service, and ramp repairs and improvements regarding the management of the lakes. The revolving fund entitled Revolving Boat Ramp Account is to be credited with all fees and charges received during FY 2011 from persons using the boat ramps. The Lake Management Committee may spend \$32,000.00 for Lake Management operations in revolving fund monies for the program during FY 2011. The unencumbered and unreserved balance in the revolving fund at the end of FY 2010 shall be carried over into FY 2011 or take any other action relative thereon.

Requested by the Lake Management Committee

Article 12 Explanation: *This vote re-authorizes the fund to keep both town boat ramps at Point Grove Road and Berkshire Avenue running for the next fiscal year. The funds are generated from launch fees to use the facilities. The volunteer Lake Management Committee has done an outstanding job keeping the facilities in great working order.*

ARTICLE 13. To see if the Town will adopt the following vote or to take any other action thereon:

Vote: to reauthorize a revolving fund under M.G.L. Chapter 44, Section 53E → that may be spent by the Police Department without further appropriation, during FY 2011 to pay for salaries, expenses, operations and contractual services regarding Harbormaster Operations for the removal and storage of snowmobiles, boats, ATV's, etc., from lakes. The revolving fund entitled "Harbormaster Revolving Account" is to be credited with all fees and charges received during FY 2011 from person(s) requiring Harbormaster services for the removal and storage of snowmobiles, boats, ATV's, etc., from lakes. Expenditures for FY 2011 shall not exceed \$20,000.

Requested by the Police Department

Article 13 Explanation: *All fees and charges imposed by the Harbormaster for services or permits related to salvage and storage will be deposited into the Harbormaster Revolving Account. Funds are generated through the issuance of permits for salvage and fees for storage imposed for removal of snowmobiles, boats, ATV's, etc. from the lake.*

Funds from this account may be used to purchase equipment for the patrol boat, equipment for the dive team, or repair or replace damaged equipment. This revolving account will allow the police department to provide quality equipment for its police officers so dive operations and boat patrols may be conducted safely.

ARTICLE 14. To see if the Town will adopt the following vote or to take any other action thereon:

Voted: To reauthorize a revolving fund under M.G.L. Chapter 44, Section 53E1/2 that may be spent by the Police Department and the Conservation Commission without further appropriation, during FY 2011 to pay for salaries, expenses, operations and contractual services regarding the Massachusetts Division of Environmental Protection Program authorized under Massachusetts General Laws Chapter 91, Local Permitting Program concerning lake water structures. The revolving fund entitled "Local Lake Permitting Revolving Account" is to be credited with all fees and charges received during FY 2011 for the permitting of lake water structures. The Police Department and Conservation Commission may spend up to \$40,000.00 for lake patrol and lake structure inspection in this revolving fund for the program during FY 2011. The unencumbered and unreserved balance in the revolving fund at the end of FY 2010 shall be carried over into FY 2011 or take any other action relative thereon.

Requested by the Police Department, Conservation Commission and Lake Management Committee

Article 14 Explanation: *This account will be used for any and all fees collected as a result of the Local Permitting Process for allowing docks on Congamond Lakes. All money in this account can only be spent only on lake related expenses in accordance with the provisions set forth in Southwick's Local Permitting Process approved by the State of Massachusetts Department of Environmental Protection.*

ARTICLE 15. To see if the Town will adopt the following vote or to take any other action thereon:

Voted: to re-authorize a revolving fund pursuant to M.G.L. Chapter 44, Section 53E → entitled "Sidewalk Revolving Account" to use the proceeds accrued from the Planning Board's waiver of sidewalks as permitted in the Subdivision of Land Rules and Regulations under Ch.315 of the Southwick Town Code for the repair, replacement and installation of sidewalks elsewhere in the community as recommended by the DPW Director and approved by the Board of Selectmen and further that said expenditures shall not exceed \$200,000 for FY 2011, or take any action thereto.

Requested by the Board of Selectmen and Planning Board

Article 15 Explanation: *Provides a fund from the Planning Board's waiver of sidewalks as permitted in the Subdivision of Land Rules and Regulations for the repair, replacement and installation of sidewalks elsewhere in the community as recommended by the DPW Director and approved by the Board of Selectmen.*

ARTICLE 16. To see if the Town will appropriate and transfer the sum of \$75,000.00 from the Sewer Capital Account for expenses incurred related to the necessary easements, appraisals, legal, engineering and other incidental costs for the Sewer Parallel Interceptor Extension in the City of Westfield, as well as the Phase 2 Collector System in the Town of Southwick.

Or take any other action thereto.

Requested by the Board of Selectmen and DPW

Article 16 Explanation: *The requested \$75,000 is to fund the necessary property appraisals, temporary and permanent easements, any damages incurred for construction of Southwick's parallel interceptor sewer extension from the current terminus on South Meadow Street to the Westfield Wastewater Treatment Plant (WWTP). The parallel interceptor design and necessary permitting have been completed by the design consultant and the easement work must be completed prior to construction. Southwick's sewage currently flows from the current terminus of Southwick's 21" interceptor via "borrowed capacity" in a 12" Westfield sewer line and limits us to 175,000 gallons per day to Westfield. Under the Southwick/Westfield Inter-Municipal Agreement (IMA) for the Phase 1 Sewer Project, the parallel interceptor extension in Westfield is required in order for Southwick to have access to the balance of its total 500,000 gallons per day purchased capacity in the WWTP. The funds would also be used for similar services in Town once a second phase is authorized.*

ARTICLE 17. To see if the Town of Southwick will vote to raise and appropriate or transfer from available funds the sum of \$8,109,414 for the Southwick-Tolland Regional School District assessment for FY 2011 commencing July 1, 2010 and ending on June 30, 2011, or take any other action thereon.

Requested by the Southwick-Tolland Regional School District

Article 17 Explanation: *Pursuant to the "Agreement Between The Town Of Southwick and The Town Of Tolland With Respect To The Formation Of A Regional School District", each member town will be, with the approval at their respective town meetings, assessed an apportionment of the annual operational and capital cost of their regional school district. The above mentioned amount is Southwick's Fiscal Year 2011 assessment share for the total Southwick Tolland Regional School District's proposed FY2011 Budget of \$18,811,644.*

ARTICLE 18. To see if the Town of Southwick will vote not to disapprove certain additional debt authorized by the Southwick-Tolland Regional School Committee under a vote dated April 6, 2010, which reads as follows:

"Voted: approve authorization to incur debt by the issuance and sale of bonds or notes for the amount of \$350,000 for the purchase of all items specified in the attached School District's FY 2011 Capital Improvement Plan" or take any other action relative thereon.

Requested by the Southwick-Tolland Regional School District

Article 18 Explanation: *Pursuant to Massachusetts General Laws (MGL), Chapter 71, Section 15(d), a regional school committee may vote to incur debt to purchase capital improvements to their buildings or grounds or equipment for the school district subject to the approval (in actuality the "disapproval") of the respective member towns. The proposed capital purchases to be made have been tentatively approved by the regional school committee and are listed in the Southwick Tolland Regional School District Proposed FY2011 Budget handout.*

ARTICLE 19. That the Town of Southwick authorize the Southwick-Tolland Regional School District to incur debt by the issuance and sale of bonds or notes in the amount of \$250,000 for a feasibility study of the Woodland Elementary School at 80 Powder Mill Road, Southwick, MA. The existing Woodland Elementary School property is located on the south side of three (3) parcels of Town owned land totaling 110 acres. The site is bordered by private wooded land and American Legion Post 338 to the south, Southwick Recreation Center and Powder Mill Road to the west, Rt. 57, Feeding Hills Road, to the north and private residences and Town owned wooded land, including the public water supply, to the east. The parcel of land is shared with Powder Mill Middle School, Southwick-Tolland Regional High School, Southwick Public Library, and playing fields utilized by the Southwick-Tolland Regional Schools and the Community at large. Said sum to be expended under the direction of the School Building Committee, and to meet said appropriation the Southwick-Tolland Regional School Committee is authorized to borrow said sum under M.G.L. Chapter 44 or any other enabling authority; that the Town and the School District acknowledge that the Massachusetts School Building Authority's ("MSBA") grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the Southwick-Tolland Regional School District incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Regional School District, and that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Feasibility Study Agreement that may be executed between the Regional School District and the MSBA.

Requested by the Southwick-Tolland Regional School District

Article 19 Explanation: *The additional \$250,000 requested in the STRSD FY2011 Capital Improvement Plan beyond the \$350,000 requested in the FY2010, is a requirement of the MSBA in order to advance our proposal for a school building construction, addition and/or renovation through Phase 1, the Feasibility Study/Schematic Design Phase. MSBA requires our member towns to approve funding to cover the full cost and at the highest contingency level for this phase of the project. The additional funding is requested because MSBA is now willing to study not only our early childhood space needs but also the renovation needs (roofs, HVAC, windows, plumbing replacement, etc.) of our other school buildings. Any and all costs incurred at this phase will be reimbursable at the 55.63% MSBA funding level. Unused and reimbursable funds will be held in a separate account that will be used to pay down the debt and/or appropriated for future use with the direction of the member towns. Phase 1 will produce a study with recommendations and cost estimates regarding the educational space needs and physical plant needs of our Early Childhood Program (Grades Pre-K to 4) at Woodland Elementary School as well as the renovation needs at Powder Mill Middle School and the Southwick Tolland Regional High School. Any request to proceed to an MSBA funded Phase 2 level, Design Development / Construction Documents / Bidding, will require a future town meeting vote from the member towns of Southwick and Tolland.*

ARTICLE 20. To act on the report of the Community Preservation Committee on the FY 2011 Community Preservation Budget and to set up a budgeted reserve for later appropriation of monies from the Community Preservation Fund annual revenues or available funds for the undertaking of Community Preservation Projects and all other necessary and proper expenses for the year. Pursuant to Massachusetts General Laws, Chapter 44B from the estimated FY 2011 Community Preservation Fund, appropriation to be set aside as follows, or take any other action relative thereto.

MOTION: To see if the town will vote to set up a budgeted reserve from the Community Preservation Fund annual revenues the amounts recommended by the Community Preservation in FY 2011 with each item to be considered a separate reserve.

- To reserve \$42,620 from FY2011 Community Preservation Fund revenues for Open Space.
- To reserve \$42,620 from FY2011 Community Preservation Fund revenues for Historic Resources.

- To reserve \$298,334 from FY2011 Community Preservation Fund revenues for FY2010 Community Preservation General Unreserved Fund.

Article 20 Explanation: *CPC FY2011 Budget based on a 3% surcharge on Residential Class One Tax bill after first \$100,000.00 value is passed. It also exempts property owned by a person who would qualify for low income housing or low or moderate income senior housing. Reserves for Historic, Housing and Open Space purposes are set aside for future projects brought back to Town Meeting for approval.*

ARTICLE 21. To act on the report of the Community Preservation Committee on the FY 2011 Community Preservation Budget and appropriate 4% (\$11,933), of the monies from the Community Preservation General Unreserved Fund for the administrative and operating expenses of the Community Preservation Committee, or take any other action relative thereto.

MOTION: To see if the Town will vote to appropriate from the Community Preservation General Unreserved Fund \$11,933 as recommended by the Community Preservation Committee.

Requested by the Community Preservation Committee

ARTICLE 21 Explanation: *CPC FY2011 Administrative & Operating expenses set aside. The statute allows 5% of the funds to be set aside but the CPC voted to set aside 4% of the funds anticipated for FY 2011.*

ARTICLE 22. To see if the Town will vote to delete in its entirety § 185-5. "Districts enumerated; maps. B." of the Code of the Town of Southwick and to replace it with the following:

§ 185-5. Districts enumerated; maps.

B. The boundaries of each of said zones set forth above in Subsection A(1) through A(9), inclusive, are hereby established as shown, defined, and bounded on a map on file in the Office of the Town Clerk of the Town of Southwick, Massachusetts, entitled "Town of Southwick, Massachusetts, Municipal Zoning Districts". This map, dated May 2010, and subsequent amendments thereto, together with explanatory matter thereon, is hereby incorporated by reference and made a part of this chapter.

Or take any other action thereto.

Requested by the Southwick Planning Board

Article 22 Explanation: *Revises the Code of the Town of Southwick, Zoning, § 185-5. Districts enumerated; maps. B. to adopt an updated Zoning Map that incorporates zoning changes approved through March 16, 2009.*

ARTICLE 23. To see if the Town will vote to amend Section 1-9 (B) of the Code of the Town of Southwick by deleting the following: **“shall be the sum of \$25.00”** and replacing the deleted portion with the following language: **“shall be up to the sum of \$100.00”** or take any other action relative thereto.

Requested by the Board of Selectmen

Article 23 Explanation: *This article amends the current Southwick Town Code non-criminal civil fine structure in place since 1992 from a \$25.00 amount to a fine “up to” \$100.00. It covers violations of by-laws, municipal officers, board or department rules and regulations. The Board of Selectmen is interested in using it as a tool for the police to gain compliance on licensing matters without having to resort to filing criminal complaints.*

ARTICLE 24. To see if the Town will authorize the Board of Selectmen to enter into a Sewer Main and Water Main Easement with Charles Berthiaume for purposes of constructing, reconstructing, installing, using, maintaining, repairing, replacing, removing or abandoning in place, inspecting and operating water mains, pipes, lines, conduits, pumps and appurtenances associated therewith over an area of land consisting of approximately 6,197 square feet, as more fully shown as “PE-1b-1” in a Plan recorded in the Hampden County Registry of Deeds in Book of Plans 321, Page 117, and the Town is not required to pay any consideration to said Charles Berthiaume for obtaining the Easement, or take any other action relative thereto.

Requested by the Board of Selectmen

Article 24 Explanation: *The DPW Water Division plans to add 300’ of water line from the northern terminus on Chapman Street to the southwestern corner of Woodside Circle along the existing Town sewer easement through property at 24 Woodside Circle belonging to Charles Berthiaume. The owner is allowing the Town to convert the existing “Town sewer” easement to a “Town sewer & water” easement for no fee.*

ARTICLE 25. To see if the Town will vote to accept as Town ways, North Pond Road and Alcove Road as shown on the lot layout plan entitled “Lot Layout Definitive Subdivision Plan North Pond Views, Southwick, Mass. For Northeast Land Development Trust, Inc. Owner, Ecotec Environmental Associates, Inc....Scale 1” = 50’ Date Sept. 1998” which plan is recorded in the Registry of Deeds for the County of Hampden in Book of Plans 311, Pages 109 and 110; and to see if the Town will further vote to authorize the Board of Selectmen to acquire by gift certain easements including an easement to use said streets for all purposes for which public ways are used in the Town of Southwick and to accept a Stormwater Drain Easement as shown on said Plan Book 311, Pages 109 and 110; or to take any other action relative thereto.

Requested by the NE Land Development Trust, Inc.
