Special Town Meeting, **February 28, 2007** at **7:00** p.m. at the Southwick-Tolland Regional High School, Feeding Hills Road in the Auditorium.

HAMPDEN SS. To either of the Constables of the Town of Southwick in the County of Hampden:

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said town qualified to vote in elections and town affairs to meet and assemble at the SOUTHWICK-TOLLAND REGIONAL HIGH SCHOOL AUDITORIUM ON, February 28, 2007 at 7:00 p.m. then and there for the Special Town Meeting and to act on the following articles:

ARTICLE 1:

To see if the Town will vote to amend the Code of the Town of Southwick by deleting, in its entirety, Chapter 28, "Fire Commissioners, Board of" and by adding a new Chapter 45 entitled "Fire Department" by accepting the provisions of M.G.L. c. 48, §42A which provides for the appointment of fire chief, other officers and firemen as follows:

"In towns which accept this section or have accepted corresponding provisions of earlier laws there shall be a fire department established under the direction of the selectmen, who shall appoint a chief of the fire department and such other officers and firemen as they deem necessary, and fix their compensation in an amount not in the aggregate exceeding the annual appropriation therefore. The selectmen may make suitable regulations governing the fire department and the officers and firemen thereof, and in towns which are not subject to chapter thirty-one may remove the chief and other officers and firemen at pleasure. The chief of the fire department shall be in immediate control of all town property used by the department, and of the officers and firemen, who shall obey his orders."

Said new Chapter 45, entitled "Fire Department" shall contain the following provision:

§45-1. Appointment of Chief, other officers and firemen.

A Chief of the Fire Department shall be appointed annually by the Selectmen. They shall also appoint such other officers and firemen as they deem necessary.

ARTICLE 2.

To see if the Town will vote to direct that all revenues received by the Town pursuant to a lease with the City of Westfield Gas and Electric Light Department, or its permitted assign, enabling the City of Westfield Gas and Electric Light Department to construct and operate a natural gas pipeline in the former railroad right of way conveyed to the Town of Southwick by the Commonwealth of Massachusetts, be paid and deposited into a separate reserve fund in the Town's Sewer Enterprise Fund to be used for operating expenditures and capital expenditures of the enterprise, or to reduce user charges, subject to further appropriation by subsequent votes of annual or special town meetings authorizing such expenditures

Or take any other action relative thereto.

ARTICLE 3.

To see if the Town will vote to rescind certain amounts authorized to be borrowed, but which amounts are no longer needed to accomplish the purposes for which they were approved, or take any other action relative thereto.

Said land is currently owned by Charles and Donald D'Amour, Trustees of Big Y Trust UDT.
