Ice/Snow Removal

Even though the winter started out mildly, we were hit with weekend ice and snow storms that were costly. This will allow the Town to close out its books in balance without a snow/ice deficit as of June 30<sup>th</sup>. Otherwise the deficit would be added to next fall's tax bill.

Sewer IMA Debt Payment The debt schedule from City of Westfield for the Southwick 25% share of the sewer Wastewater Treatment Plant upgrade changed mid year from Mass Water Pollution Abatement Trust Bond Closing as the funding agency. This notification happened in between vacancies in the Treasurer/Collector position. This account has been recalculated for Fiscal 2008.

Library Utilities \$1,000.00 Budgeted amounts came in short of escalating costs for utilities

The Finance Committee shall investigate the cost of maintenance and expenditures of all Town offices and departments and report to each Town Meeting its recommendations as to all Articles in the warrant involving the expenditures of money or the disposition of any property of the Town.

<u>Proposed:</u> §24.2. Powers and duties.

The Finance Committee shall investigate all proposals in the articles of the warrant for any Town meeting that shall in any way affect the finances of the Town and recommend to the Selectmen and Town at lease 7 days prior to the time of said meeting a course of action thereon. Said recommendation shall include a 1 paragraph summary of the article, as well as the pros and cons of each Article. The Finance Committee shall consider all matters relating to the appropriation, the borrowing and the expenditure of money by the Town, its indebtedness, the administration of its various offices and departments, and may make recommendations to the Town or to any board, officers or committee relative to the municipal fiscal affairs. In general, it shall make recommendations to the Town in regard to any financial business of the Town. In the discharge of its duties, individual members of the Committee shall have free access to all books of record and account, bills and vouchers on which money has been or may be paid from the Town Treasury, contracts, agreements, and any other documents (printed or electronic) relating to financial matters of the Town.
