ARTICLE 1. To see if the Town will vote to appropriate and transfer from available funds (General Salary Reserve, Water and Sewer Salary Reserve) the sum of \$61,747.00 for the following salary accounts:

ARTICLE 1 EXPLANATION: This transfer from existing funds covers negotiated agreements for staff and cost of living adjustments for 36 non-union staff for the present fiscal year. These funds come from several Salary Reserve Accounts and available funds, set aside to cover these costs. Funds also cover backfill expenses for people out with on the job injuries and sickness.

ARTICLE 2. To see if the Town will vote to appropriate and transfer the sum of \$288,500.00 from available funds (Free Cash & Water Retained Earnings) for the following Operational Line items or take any other actions relative thereto

Requested by the DPW, Town Accountant, and Select Board

ARTICLE 2 EXPLANATION: The Town experienced snow and icing events beyond what was budgeted, some of which required overtime and the use of outside hired vendors. The cost of road salt to treat roads contributed heavily to these expenses. This will allow the Town to close out its books in balance without a snow/ice deficit as of June 30th. Otherwise the deficit would be added to next fall's tax bill.

- The Southwick Police Department experienced higher than anticipated repairs to cruiser vehicle fleet.
- Park n' Recreation needs funds to rehabilitate a large mower used for railtrail mowing to ensure trail is regularly mowed for users.
- The DPW Water Division had an unexpected retirement in the last couple of months. Finance Committee Funds were used to cover expense temporarily and these funds reimburse the account.

ARTICLE 3. To see if the Town will vote to appropriate and transfer from available funds (Free Cash) the sum \$363,800.00 in connection with the following Capital Items or take any other action relative thereto.

ARTICLE 3 EXPLANATION: Funds are requested to replace failing bridges and culverts. These funds leverage a \$500,000.00 MassDOT Grant Award for replacement of a culvert at Shurtleff Brook on North Loomis Street. The project has been structured to leave one lane open at all times for emergency response purposes.

- Approval of funds will allow the Town to secure a new 4 wheel truck for Buildings/Grounds and transfer the older 2 wheel drive vehicle to Park and Recreation for summertime seasonal operations.
- The Conservation Commission requires a new updated computer work station specified to run its' Arc View Mapping Programs.
- Replacement tires are needed for the Building Inspector car and the Southwick Fire Department truck fleet due to both age and use.
- The Planning board needs a vertical file cabinet to keep increased number set of plans coming into office in a secured place. Current units at max capacity.

ARTICLE 4. To see if the Town will vote to appropriate and transfer from available funds (Free Cash) the sum of \$20,000.00 to the Other Post Employment Benefits Trust Fund (O.P.E.B.) established under the provisions of M.G.L Chapter 32B, Section 20 or take any other actions relative thereon.

Requested by Town Accountant

ARTICLE 4 EXPLANATION: This article allows us to make our annual deposit to the Other Post Employment Benefit (OPEB) Trust Fund established at a Town Meeting several years ago. The Town currently pays for post employment health care expenses on a pay as you go basis. This type of fund, which was authorized by State law, provides a tool for municipalities to recognize the liability and begin to cover future costs. Eventually this fund will hold several hundred thousand dollars to cover health costs. Annually contributing to it is recommended by our outside Auditors and is looked upon favorably by our Bond Rating Agencies.
